Description: MAP measures achievement and growth in K–12 math, reading, language usage, and science. It provides teachers with accurate, and actionable evidence to help target instruction for each student or groups of students regardless of how far above or below they are from their grade level. MAP Growth student reports also present realistic learning goals by subject areas so that, through a teacher’s guidance, students can individually see their progress and be inspired to take charge of their own learning.

Historical Data: We used the MAP screener last year in the three MESA Academies. We also used MAP three years ago to progress-monitor students.

Recommendation: Approve the quote for NWEA MAP not to exceed \$117,562.50.
