# B. Legislative Report

Supt. O'Neill reported Gov. Whitmer released her first budget proposal which calls for increased revenue by increasing the gas tax. She has more allocated funds toward education which is very positive for Michigan schools. The Educator Evaluation Bill is in the Senate and still needs to go through the House. The snow day legislation is moving slowly, but hopefully there will be a vote tomorrow so it can move to the Senate.

A Public Hearing for the pre-Labor Day start of school is scheduled for Thursday, April 18, 2019 at KRESA. This requires a county-wide waiver.

    Asst. Supt. Goss presented the monthly budget progress report for March 31, 2019 showing total revenues of \$16,570,293; total expenditures of \$17,295,636 and a deficiency of revenues over expenditures of \$(725,343).

This allows for continuous upgrades and keeps the millage rate consistent. There will be a recommendation for transportation equipment purchases at the next board meeting.
