
2. Provide a detailed explanation of how the services being waived will be provided for students.

#### Resolution of the Palestine-Wheatley Board of Directors

#### Title: Request for Waiver on School Start Date

Whereas, An earlier start date is deemed essential for optimizing the educational experience for students and addressing specific logistical considerations;

Now, therefore, be it resolved, that the Palestine-Wheatley Board of Education hereby authorizes and empowers the Superintendent to submit an official request to the Arkansas Department of Education for a waiver allowing Palestine-Wheatley to commence the school year before the mandated August 19th start date,

**Be it further resolved,** that the Superintendent is directed to provide a comprehensive justification for the waiver request, outlining the educational benefits and logistical justifications for an earlier start date;

Be it further resolved, that the Superintendent is authorized to collaborate with relevant educational stakeholders, including parents, teachers, and administrators, to gather input and support for the waiver application;

Be it further resolved, that the Superintendent shall keep the Board of Education informed of the progress and outcome of the waiver application process;

Be it further resolved, that the Palestine-Wheatley Board of Education expresses its commitment to providing the best possible educational environment for its students and believes that flexibility in determining the school start date is integral to achieving this objective.
