DATE OF MEETING: March 26, 2013

TITLE: Approval of Out of State Travel

BACKGROUND:

STUDENTS

Bobby Brush from Ironwood Ridge High School and Terri Bible from Canyon del Oro High School, request permission to take 6 students from DECA to Anaheim, California, April 23-28, 2013. Approximate cost of the travel is \$8,608 and will be paid for by JTED funds, tax credits, auxiliary funds, and student activity funds. Four school days will be missed and a substitute is required.
