Given that Whittier School, along with Mann School, would be having the secured entrance work completed this summer, thus insuring that all 10 buildings in District 97 would have secured entrances, and recognizing that Whittier, along with Holmes & Irving Schools, do not have their auditoriums air-conditioned, it was decided to let a bid for this work. The primary reason for addressing Whittier at this time was to capitalize on closing the building for solely one summer rather than perhaps two years in a row. The associated cost for this work was not anticipated in the 5-year capital plan. It was estimated that the cost of this work would be approximately \$160,000.

An appropriate legal notice was published in the <u>Oak Leaves</u> on January 19, 2012 announcing a bid opening on February 2, 2012 (see attached legal notice). Apart from the legal notice, 12 contractors were invited to bid by DLA Architects (see attached bidders' list) and, on February 2, 2012, six bids were received, ranging from a low of \$176,800 to a high of \$240,800 (see bid tab summary). We have sufficient dollars in our most recent DSEB (Debt Service Extension Base) borrowing (\$5,200,000) to cover the cost of this work.

The District's architectural firm has recommended award of a contract to F. E. Moran in the total amount of \$176,800 recognizing that this firm is the low bidder and "has experience with similar projects". The Director of Buildings & Grounds and I are recommending support in awarding this bid to F.E. Moran.

This will return to the Board of Education for formal approval at its February 28, 2012 meeting.
