## 1. Opening of Meeting

## 2. Board Matters

- We are working to fill the Board vacancy position created by President Bland, who is now seated on Southfield's City Council.

## 3. Report of the Student Board Representatives

**a. Paris Whitman: Southfield High School for the Arts & Technology (SA&T)**

- As we enter December, a month filled with celebrations like Christmas, Kwanzaa, Hanukkah, and other traditions families honor in their own way, we are reminded of the importance of togetherness, gratitude, and supporting those we care about. This season highlights the strength of our community and the Warrior spirit we show through kindness and connection.

**• Sports Highlights:**

- Winter Sports: have officially begun and our teams are already making momentum.
- Boys' Basketball opened the season with a strong win on the road against East English Village Prep Academy.
- Wrestling Team began their season with their first match against Warren Lincoln.
- Bowling is off to a great start. Their most recent competition was against North Farmington.
- Girls' Basketball will make their home debut on December 12, 2025, which doubles as Middle School Night. Let's fill those stands with support and Warrior spirit.
- Competitive Cheer tryouts have wrapped up. The cheerleaders have started practicing and building their routines.
- The Warriors Marching Band has had a busy successful season. They participated in the Harvest Fest at UK12, where they completed six rounds against ten different schools in an event hosted by Levey Middle School. - These changes are effected by our benefits and we want to be competitive with our salaries. We have declining enrollment.
- We are going to have some difficult conversations as they relate to contracted services.
- Secretary Smith-Thomas and President Ware-DeVaull agree that we need to set a date for a budget study session that specifically walks through this audit and identify some of the spending and budget trends as well as the alignment to the services offered. We should also look at transportation routes and verify any trends now as opposed to the beginning of the year.
- Secretary Smith-Thomas states that she would also like to see the trends for our enrollment loss specifically at what grade level.
- Treasurer Belk would like the meeting to include the information regarding the Athletic Department overspend so that the board is fully aware of how that will be corrected moving forward.
- The oversight to the Athletic Department was regarding the invoices that were not accounted in June. The invoices came in after the June 30<sup>th</sup> deadline. The Finance Department had to go in and journal entry all of those invoices. Coach Q and her team have come up with a proactive plan on how to avoid that issue moving forward.
- There was a finding from 2023 federal awards audit regarding food service. It has been corrected and submitted to the federal government and to the state of Michigan.
- Our previous Board President and Treasurer Belk met with the auditors separate and apart from the Finance Department to make sure that all of the questions that arose from the Trustees were answered.

**b. Report 64-33 Southfield Public Schools: 2026 School Building and Site Bonds Resolution**

- The Board now desires to authorize the issuance of the third series of bonds authorized pursuant to the 2022 Bond Proposal in an aggregate principal amount not to exceed one hundred million dollars (\$100,000,000) to pay a portion of the costs of the projects and the costs associated with issuance of the bonds; and the School District also deems it advisable to authorize the Superintendent and the Chief Financial Officer and Operations Officer, or either one acting individually (the "Authorized Officer"), to accept an offer to purchase the bonds from an underwriter, negotiate, approve and execute a bond purchase agreement with the underwriter and to approve various other terms and documents in connection with the sale and delivery of the bonds to the underwriter; and the School District must either be granted qualified status within the meaning of Act 34, Public Acts of Michigan, 2001, as amended (the "Act"), or receive prior approval of the bonds from the Michigan Department of Treasury ("Treasury").
- Treasurer Belk moved to open and approve Report 64-33 Southfield Public Schools: 2026 School Building and Site Bonds Resolution and it was supported by Trustee Denson.
- This is not for additional money. This is to take the bonds to market.

President Ware-DeVaull asked Secretary Smith-Thomas to call for the vote.

**c. Swing Space Building Readiness**

- We have held meetings with our Birney K-8 families regarding the transition to the two different swing spaces on January 5, 2026 for the second semester of 2026 school year. Our K-5 students

will be at Vandenberg Elementary and our 6-8 grades will be at Southfield Regional Academic Center (SRAC).

- Our bond and operations teams have been working to ensure these spaces are ready to receive our scholars on January 5, 2026. The movers will come on December 15 and December 16, 2025 to move some of the furnishings over to the two new respective locations.
- Dr. Green and Mrs. T.J. will walk the campuses to ensure their readiness. There will be contractors coming into the spaces for some last minute touches.
- There will be one final virtual meeting on December 16, 2026 for those parents that have not been able to attend any of the other virtual meetings. We will ask Principal Baldwin to share that link again for those parents that may have missed it.
- We will ensure the Board gets an updated report on the readiness of Vandenberg and Southfield Regional to receive our scholars in January 2026.

**d. Staffing Update**

- Dr. Green went over the Staffing Update presentation.
- There are a lot of special education positions being filled by a substitute.
- Per MDE, you have to hold an undergraduate degree. It does not have to be an undergraduate degree in education. The individual can only sit in those positions for 90 calendar days. We have some staff members that are on alternate tracks with Talent Together and Teach for America. The staff members on the alternate track have waivers for the year. The individuals in the substitute positions have to exit those positions every 90 calendar days.
- We need to discuss ways to develop an internal pathway to strategically place people or candidates for our most vulnerable scholars.
- We sit down with the individuals that are not on the alternate track to see if the alternate tracks are a viable route for them and some of them are not interested in the alternate route. We work with the individuals that are interested in the alternate route to find that viable program.

### a. Report 64-35 BDS Environmental – Asbestos Abatement (Southfield A&T O-House): Bond Funds

- The Bond Team recommends awarding the asbestos abatement services to BDS Environmental. The work scope encompasses the necessary services for this project. This recommendation will be

funded out of the 2022 Bond proceeds. The total award recommendation is for \$711,150 including contingency based on the BDS Environmental bid of \$646,500.

**b. Report 64-36 Arch Environmental Group – Environmental Consulting Services: Project Coordination and Air Monitoring (Southfield A&T O-House): Bond Funds**

- For the scope of services described and requested, as modified: The amendment adds Asbestos project coordination and air monitoring environmental consulting services at SA&T O-House Compensation for these services is a fixed fee of \$74,800. A breakdown of the Total Authorized Compensation is provided below:
- Previously Authorized Compensation: Fixed Fee - \$290,500, Total Authorized Compensation - \$290,500
- Asbestos Project Coordination at SA&T O-House: Fixed Fee - \$74,800, Total Authorized Compensation - \$365,300

**c. Report 64-37 G2 Consulting Group – Professional Surveying (Extended Underground Utility @ UK12 & SA&T): Bond Funds**

- For scope of services described and requested, as modified: The amendment adds additional services for SA&T, UK12, and the fire station. Total compensation for these services is \$34,900.00. A breakdown of total compensation is provided:
- Previously Authorized Compensation: Lump Sum - \$204,800, Total Authorized Compensation - \$204,800
- SA&T: Lump Sum - \$15,750, Total Authorized Compensation - \$220,550
- UK12: Lump Sum - \$9,850, Total Authorized Compensation - \$230,400
- Fire Station: \$9,300, Total Authorized Compensation - \$239,700

**d. Report 64-38 Fanning Howey Associates – Professional Surveying Services (Extended Underground Water, Storm, and Sanitary Utility @ UK12 & SA&T): Bond Funds**

- For scope of services described and requested, as modified: The amendment adds professional surveying services at SA&T and UK12. Total compensation for these services is a fixed fee of \$93,650. A breakdown of total compensation is provided below:  
Previously Authorized Compensation: Fixed Fee - \$9,138,998, Total Authorized Compensation - \$9,138,998

SA&T Underground Utility: \$19,900, Total Authorized Compensation - \$9,158,898

UK12 Underground Utility: \$33,150, Total Authorized Compensation - \$9,192,048

UK12 Underground Utility: \$16,800, Total Authorized Compensation - \$9,232,648

- We are using our firewall separations for the division of the abatement areas and the students as required by the State of Michigan. Arch Environmental will also monitor air quality to ensure acceptable levels.

**f. Financial Report****g. Monthly Bill Disbursement**

- Treasurer Belk stated that based on the current bill disbursements and monthly financial reports we appear to be on track to remain within the board approved fund balance targets as long as our revenue continues to be the same. The District is financially stable at this point in the fiscal year. Treasurer Belk stated that there were some findings with transportation. We were trending higher than normal. The variances were primarily due to June's invoices being omitted and they have been corrected. Fiscal year 2026 was built using the understated fiscal year 2025, which is where the misalignment occurred. We will continue to monitor transportation cost closely. Treasurer Belk spoke with Dr. Green regarding the 30-day meeting with transportation. She wants to continue to have oversight and transparency for our district. Treasurer Belk has a meeting with the finance team to go over the differences between our system generated statuses and true payment reversals.
- 31aa is a funding source from the State of Michigan to help with security measures in the district. It is approximately \$575,000. The State budget has certain language written into it this year that requires us to waive certain privileges all school districts have. With that language, our Trustees elected not to approve it because it would put the district in jeopardy. With the state and federal filings, we will know by December 31, 2025 if we are in or out depending on the court's ruling.
- We need to make sure we are having the discussions with the UK12 community regarding their move.
