

**#5020.1
Non-Discrimination**

5 The Board of Education (the “Board”) complies with all applicable federal, state and
6 local laws prohibiting the exclusion of any person from any of its educational programs
7 or activities, or the denial to any person of the benefits of any of its educational programs
8 or activities because of race, color, religion, age, sex, sexual orientation, marital status,
9 national origin, alienage, ancestry, disability, pregnancy, gender identity or expression, or
10 veteran status, subject to the conditions and limitations established by law.

12 It is the policy of the Board that any form of discrimination or harassment on the basis of
13 race, color, religion, age, sex, sexual orientation, marital status, national origin, alienage,
14 ancestry, disability, pregnancy, gender identity or expression, or veteran status, or any
15 other basis prohibited by state or federal law is prohibited, whether by students, Board
16 employees or third parties subject to the control of the Board. The Board’s prohibition of
17 discrimination or harassment in its educational programs or activities expressly extends
18 to academic, nonacademic and extracurricular activities, including athletics. It is also the
19 policy of the Board to provide for the prompt and equitable resolution of complaints
20 alleging any discrimination on the basis of protected characteristics such as race, color,
21 religion, age, sex, sexual orientation, marital status, national origin, alienage, ancestry,
22 disability, pregnancy, gender identity or expression, or veteran status.

24 For the purposes of this policy, “veteran” means any person honorably discharged from,
25 or released under honorable conditions from active service in, the United States Army,
26 Navy, Marine Corps, Coast Guard and Air Force and any reserve component thereof,
27 including the Connecticut National Guard.

29 For the purposes of this policy, “gender identity or expression” means a person’s gender-
30 related identity, appearance or behavior, whether or not that gender-related identity,
31 appearance or behavior is different from that traditionally associated with the person’s
32 physiology or assigned sex at birth, which gender-related identity can be shown by
33 providing evidence including, but not limited to, medical history, care or treatment of the

34 gender-related identity, consistent and uniform assertion of the gender-related identity or
35 any other evidence that the gender-related identity is sincerely held, part of a person's
36 core identity or not being asserted for an improper purpose.

38 Any student and/or parent/guardian wishing to file a complaint regarding discrimination
39 may obtain a copy of the Board's complaint procedures and complaint form, which are
40 included in the Board's Administrative Regulations Regarding Non-
41 Discrimination/Students. These regulations accompany Board Policy #5020.1 and are
42 available online at <https://www.madison.k12.ct.us/board-of-education/policies> or upon
43 request from the main office of any district school.

45 If a complaint involves allegations of discrimination or harassment based on reasons such
46 as gender/sex, disability, or pregnancy, such complaints will be handled under other
47 appropriate policies (e.g., Policy #5120.4.2.4, Sex Discrimination and Sexual Harassment
48 and Policy #5200, Section 504/ADA).
