## Approving Memorandum of Understanding Between Browning Public Schools and Sukapi Lodge Mental Health Center

WHEREAS, The Blackfeet Tribal Business Council is the duly constituted governing body within the exterior boundaries of the Blackfeet Indian Nation pursuant to the Constitution and By-Laws for the Blackfeet Tribe of the Blackfeet Indian Reservation of Montana, 1935 and amendments thereof, and

**WHEREAS,** The Blackfeet Tribal Business Council has been organized to represent, develop, protect and advance the views, interests, health, education, welfare and resources of the Blackfeet Indian Reservation, and

WHEREAS, The Blackfeet Tribal Business Council pursuant to Article VI, Section 1(g) of the Blackfeet Constitution, is empowered to manage tribal affairs in an acceptable and businesslike manner, and

WHEREAS, Sukapi Lodge Mental Health Center wishes to enter into a Memorandum of Understanding with Browning Public School District #9 to establish roles and define responsibilities of the Parties to develop and implement a comprehensive school mental health system (CSMHS) that utilizes the strengths and expertise of school and community-partnered professionals.

WHEREAS, The Blackfeet Tribal Business Council is aware of Sukapi Lodge Mental Health Center's desire to enter into an MOU with Browning Public Schools, and that the Blackfeet Legal Department has reviewed and approved the proposed MOU between both parties.
