B) ALEX Coordinator Report

Korolewski spoke about the successes in the ALEX Program. The program is in the 5th year of Life Space Crisis Intervention ("LSCI") seeing positive results with students and staff. Some students are starting to slowly transition back to their home districts. More students come to ESY this summer than in the past. CVSEC just renewed the CTSS license with the state. There are only a few districts in the state that have this accreditation. ALEX has two new teachers this year. Staff are excited to work with the students and find it fun and challenging. There has been increased engagement with families reaching out to staff. ALEX continues to have other school districts such as Hennepin and Davenport, Iowa visit and observe the program.
