

Paragraph for Board Memo:

Mrs. Tiffany Douglass requested the following records:

- “Number of students at Geneva High School who have been quarantined due to close contact with a positive CoVid student at Geneva High School during in-person learning between August 31, 2020 and March 26, 2021.
 - Number of students at Geneva High School who have tested positive for CoVid during their close contact quarantine period* between August 31, 2020 and March 26, 2021 .
 - Number of students at Geneva Middle School North who have been quarantined due to close contact with a positive CoVid student at Geneva Middle School North during in-person learning between August 31, 2020 and March 26, 2021 .
 - Number of students at Geneva Middle School North who have tested positive for CoVid during their close contact quarantine period* between August 31, 2020 and March 26, 2021 .
 - Number of students at Geneva Middle School South who have been quarantined due to close contact with a positive CoVid student at Geneva Middle School South during in-person learning between August 31, 2020 and March 26, 2021 .
 - Number of students at Geneva Middle School South who have tested positive for CoVid during their close contact quarantine period* between August 31, 2020 and March 26, 2021.

- Number of students at Williamsburg Elementary School who have been quarantined due to close contact with a positive CoVid student at Williamsburg Elementary School during in-person learning between August 31, 2020 and March 26, 2021.

 - Number of students at Heartland Elementary School who have been quarantined due to close contact with a positive CoVid student at Heartland Elementary School during in-person learning between August 31, 2020 and March 26, 2021.
 - Number of students at Heartland Elementary School who have tested positive for CoVid during their close contact quarantine period* between August 31, 2020 and March 26, 2021.
 - Number of students at Western Avenue Elementary School who have been quarantined due to close contact with a positive CoVid student at Western Avenue Elementary School during in-person learning between August 31, 2020 and March 26, 2021.
 - Number of students at Western Avenue Elementary School who have tested positive for CoVid during their close contact quarantine period* between August 31, 2020 and March 26, 2021.

- Number of students at Fabyan Elementary School who have been quarantined due to close contact with a positive CoVid student at Fabyan Elementary School during in-person learning between August 31, 2020 and March 26, 2021.
- Number of students at Fabyan Elementary School who have tested positive for CoVid during their close contact quarantine period* between August 31, 2020 and March 26, 2021.
- Number of students at Mill Creek Elementary School who have been quarantined due to close contact with a positive CoVid student at Mill Creek Elementary School during in-person learning between August 31, 2020 and March 26, 2021.
- Number of students at Mill Creek Elementary School who have tested positive for CoVid during their close contact quarantine period* between August 31, 2020 and March 26, 2021.
- Number of students at Harrison Elementary School who have been quarantined due to close contact with a positive CoVid student at Harrison Elementary School during in-person learning between August 31, 2020 and March 26, 2021.
- Number of students at Harrison Elementary School who have tested positive for CoVid during their close contact quarantine period* between August 31, 2020 and March 26, 2021.
- Total number of students at all Geneva CUSD 304 schools that have been quarantined due to close contact with a positive CoVid student during in-person learning between August 31, 2020 and March 26, 2021.
- Total number of students at all Geneva CUSD 304 schools who have tested positive for CoVid during their close contact quarantine period* between August 31, 2020 and March 26, 2021.
- Symptom logs kept by students/parents during their close contact quarantine period* or a spreadsheet compilation of student temperatures/symptoms during their close contact quarantine period* between August 31, 2020 and March 26, 2021.

*close contact quarantine period being defined as the period of time a student has been required by the school to quarantine after being identified as a close contact to a CoVid positive case during in-person learning at school.”

This FOIA request was received April 26, 2021, and responded to on May 3, 2021. It took two District employees a total of 2 hours 40 min (\$107.77) to respond to this FOIA request. Total attorney time equaled 40 minutes (\$126).
