
- Zone 1: Amity, Dayton, McMinnville, Perrydale, Sheridan, Willamina or Yamhill-Carlton School District



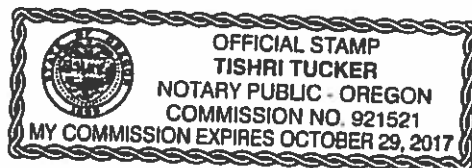


