#### I. SUPERINTENDENT'S REPORT

- A. Recognition United Way Challenge Award to Jake Biernacki Tonya Nash and Laura Howard: Laura Howard, Vicksburg United Way Chair, stated that a competition was held between Gull Lake and Vicksburg to compare the percentage of increase in individuals and business and overall dollars raised from previous year. Vicksburg won the challenge. The Indian Lake STEAM Project was the recipient of the \$1,000 prize. Sue Moore, Tonya Nash, Dana Downing, Travis Cree, Cindy Kole, and Mike Larson were present. Mr. Biernacki shared video of examples of the STEAM Project at Indian Lake.
- B. Student Enrollment Count Day February 10, 2016: The second count date of the school year is February 10.
- C. Legislative Report: Supt. Glaes stated that Judge John Corbett O'Meara issued an order granting a preliminary injunction on PA269, which means the law cannot be enforced until further order of the court. This lifts the gag order that was currently affecting the more than 100 local districts and communities that have March elections. Rep. Dave Maturen was commended for urging the Governor to vote no or make revisions to the bill.
- D. Important Dates: Supt. Glaes referred to dates listed on the agenda including a couple of date changes.
- E. Days/Hours Update: The district is in very good shape with days and hours having only had one full day closure and one 2 hour delay.

#### II. REPORTS AND PUBLIC INQUIRY

- A. Business and Finance Report Steve Goss
  - 1. Budget Progress Report for the Month Ending January 31, 2016: Asst. Supt. Goss reviewed the budget progress report for January, 2015 showing total revenues of \$10,525,366; total expenditures of \$11,664,757; and deficiency of revenues over expenditures of -\$ (1,139,391).
  - 2. Bond Update: Asst. Supt. Goss recapped summer bond projects and reviewed the 2016 School Building and Site Bonds, Series II Proposed Schedule of Events. Mr.

Goss requested Board approval of contracts, listed in action item, at a total cost of \$1,747,998.

3. Bus Purchase Recommendation: Mr. Goss reviewed the district bus replacement plan in which 1/3 of the bus fleet was replaced in 2013 and will be paid off in June, 2016. Mr. Goss and Mrs. McKinstry requested approval to order eight busses through the MSBO School Bus Purchasing Cooperative, as we have in the past, with a total purchase price of \$692,584. In addition, Mrs. McKinstry will be making a recommendation for the purchase of two Suburbans (or equivalent) later this spring at an estimated purchase cost of approximately \$100,000-\$110,000.
