- 4. Board discussion regarding seeking replacement for the position of Greenbush Middle River Superintendent
 - Board Chair Kilen reported that the Badger School District had met with their Staff on May 20th at 4:00 pm and then met in a Special Meeting on May 21st at 7:30 am to discuss how to proceed upon the resignation of Supt. Jerome.
