## Discussion Items

**CESA 10 Referendum Update Presentation** – Luke Schultz from CESA 10 provided a referendum project update to the Board. Many of the phase 1 items are near completion, including – roofing, phase 1 flooring, water heaters, lighting, exterior improvements, elevator upgrade, science casework, track patching and restriping, controls upgrade, and other mechanical upgrades. Many of phase 2 items will go to bid in November, including – bus garage upgrades, career and tech ed upgrades, cement fixes, District Office vestibule window, flooring, gyms, locker rooms, restrooms, student lockers, and painting.

**Bathroom Upgrades** – The Board discussed the process for the bathroom upgrades and ADA compliance.

**Digital Wall of Fame** – The Board reviewed the quote for the Digital Wall of Fame and discussed alternative funding options. Mr. Kaiser will look for donors.

**Bus Cameras Upgrades** – The Board reviewed the quotes for new bus cameras to improve our safety and security for ten buses and one van.

Review the Secondary Referendum Items from the Facilities Study – The Board reviewed additional secondary referendum items to consider.

**Questions, Topics, and Highlights for Upcoming Director's Reports** – The Board prepared discussion items for upcoming IT and Athletic Director reports.
