There will be a final discussion, and the Tax Rate for 2017 will be set at the regular meeting of the Board of Trustees of Collin County Community College District on August 22, 2017.

2017-8-3-2 Presentation of the Proposed 2017-2018 Budget

Ken Lynn of Administrative Services presented the proposed 2017-2018 Budget to the Board of Trustees. He reviewed the budget detail in a slide presentation. On August 1, 2017, Mr. Lynn presented the proposed budget to the Finance and Audit Committee. Five of nine board members were in attendance at the meeting for the presentation and discussion. This is the second opportunity for the Board of Trustees to hear the budget presentation and the first opportunity for public presentation. The proposed budget for Fiscal Year 2017-2018 was presented as follows:

President Matkin said that last year the board approved policy changes regarding 3peat classes, which resulted in an estimated \$500,000 for the college by that one change.

In answer to Dr. Collins' question about the transfer from the building fund, Mr. Lynn said the funds were transferred out of unrestricted funds to the new Startup and Stabilization Fund.

In answer to Mr. Moses' question about whether property taxes included maintenance and debt service, Mr. Lynn said it included only maintenance and operations.

Mr. Hardin said it was a good summary and he would love to have a copy of Mr. Lynn's presentation. He asked Mr. Lynn to share it with the board secretary so she could send it to the board members.

President Matkin explained why the recommended salary increase was 3.5% this year instead of 4% like last year. He said every year at this time Kim Davison along with Floyd Nickerson and the Human Resources staff construct and look at the consumer price index as well as certain costs across the county. The good news is that the cost of items and supplies has decreased year over year and, while we want to be sensitive to maintaining the best labor force we can maintain and reward our employees, we have a method we use to come up with the recommendation based on those factors.

No action was required nor taken.

The motion was seconded by Ms. Wurzman and received unanimous approval.
