FOURTH EXTENSION OF PUPIL TRANSPORTATION SERVICES AGREEMENT BETWEEN INDEPENDENT SCHOOL DISTRICT 256, RED WING PUBLIC SCHOOLS AND FIRST STUDENT, INC.

THIS AMENDMENT is made and entered into as of the day of , 2024 by and between Independent School District 256, Red Wing Public Schools with principle offices at District Office, 2451 Eagle Ridge Drive, Red Wing, Minnesota 55066 ("District") and First Student, Inc. with its national headquarters at 191 Rosa Parks Street, 8th Floor, Cincinnati, OH 45202 and local business offices for purposes of this Agreement located at 11911 Champlin Drive, Champlin Minnesota 55316 ("Contractor" and, collectively, the "Parties").

WHEREAS, the parties entered into that certain Student Transportation Agreement dated July 1, 2016 (hereinafter the "Agreement"); and

WHEREAS, the parties desire to further extend the term of the Agreement;

NOW, THEREFORE, the parties mutually agree as follows:

- **1.** <u>TERM.</u> The term of the Agreement shall extend for two (2) additional years commencing July 1, 2024 and continuing through June 30, 2026.
- 2. <u>COMPENSATION.</u> Commencing July 1, 2024, the rates of compensation payable hereunder during the ensuing Contract Years 2024-25 and 2025-26 shall be as listed in Appendix A which is attached hereto and made a part hereof and are based on current number of routes.
- 3. <u>NOTICE TO PARTIES.</u> All notices to be given by the parties to this Agreement shall be in writing and serviced by depositing same in the United States Mail, certified mail.
