## III. FY 18 Budget

Discussion:

Mr. Izzo informed the Board about the process so far. We met with the Budget committee several times and with the building principals.

Mr. Izzo discussed the Governor's Proposed Budget which will not be finalized until the first week of June. The Governor and legislators are making a proposal to change the date that municipalities have to submit their budgets to be aligned with the legislature due to the upcoming fiscal budget

Mr. Izzo reviewed line items.

• Salary is up by roughly 2.87% and is driven by union contracts. Paraprofessional contract is currently being negotiated.

- Benefits has a slight reduction of -0.31%
- Professional Services is up slightly. This category includes substitutes for the district and retiree reimbursement (two more years left for the last cohort).
- Supplies and materials is basically flat.Property Services has a reduction of -5.41% due primarily to a decrease in utility costs.
- Other Purchased Services is up by 13.90%due largely to Special Education costs. Mr. Izzo met with Mrs. Sheridan and we have gained three (3) new students in the last month or so. We also have an increased population of students attending magnet schools.
- Our total budget is up by 4.32% driven mostly by salaries, special education and contracted costs.
