1) Expansion LEA: Responsive Education Solutions is seeking to add an additional LEA to Founders Classical Academies of Arkansas charter for the 2022-2023.

The new LEA, Founders Online, will serve as a virtual campus for FCA students across the state of Arkansas.

1) To increase the district enrollment cap to **3000 students** to reflect an additional virtual LEA of 500 students.

The virtual LEA will have an enrollment cap of five hundred (500) students.







# **Amendment Request**

- 1. Expansion LEA: FCA of Arkansas is seeking to add an virtual school for grades K-12 beginning in the 2022-2023 SY.
- 2. Increase enrollment cap to **3,000 students** to reflect virtual LEA expansion.



#### WAIVERS

All waivers requested currently exist in the Founders Classical Academy District Charter.

All "new" additional waivers outside of existing waivers are requested only due to the lack of a physical building for the virtual LEA.

These waivers will only be applicable to the virtual LEA to meet AR DESE Standards of Accreditation.
