APPROVAL OF THE PREVAILING WAGE ACT

Each year, the Board of Education, by state law, is required to pass a resolution in compliance with the Prevailing Wage Law, section 39S-9. This law requires that each public body, during the month of June, investigate and ascertain the prevailing rate of wages as defined in the public act, then post this information or keep it available for inspection by interested parties.

We have received from the Illinois Department of Labor a copy of their prevailing wage rates. The resolution announces that contractors doing business with the school district in certain construction projects must pay prevailing wages. Once the Board has passed this resolution, we will send certified copies as required by the law to the Illinois Department of Labor and the Secretary of State. Also, within thirty (30) days after the Board has passed this resolution, a copy of the same will be published in a local paper giving notice to all interested parties.

ILLINOIS PREVAILING WAGE ACT RESOLUTION

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics, and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, codified as amended, 820 ILCS 130/1 et seq. (1993), formerly Ill. Rev. Stat., Chapter 48, paragraph 39s-1 et seq. And

WHEREAS, the aforesaid Act requires that the Board of Education of the Libertyville School District #70 investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics, and other workers in the locality of Lake County employed in performing construction of public works, for said Libertyville School District #70.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF EDUCATION OF LIBERTYVILLE SCHOOL DISTRICT #70:

SECTION 1: To the extent and as required by "An Act regulating wages of laborers, mechanics, and other workers employed in any public works by State, county, city or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics, and other workers engaged in construction of public works coming under the jurisdiction of the Libertyville School District #70 is hereby ascertained to be the same as the prevailing rate of wages for construction work in Lake County area as determined by the Department of Labor or the State of Illinois as of June 2018 a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the Libertyville School District #70. The definition of any terms appearing in the Ordinance, which are also used in aforesaid Act, shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Libertyville School District #70 to the extent required by the aforesaid Act.

SECTION 3: The Libertyville School District #70 Secretary shall publicly post or keep available for inspection by any interested party in the main office of this Libertyville School District #70 this determination or of the current revised determination of such prevailing rate determination of prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: The Libertyville School District #70 Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The Libertyville School District #70 Secretary shall promptly file a certified copy of Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

SECTION 6: The Libertyville School District #70 Secretary shall cause to be published in a newspaper of general circulation within the area a copy of this Ordinance, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
