

### What is the Purpose of IDEA Grant Spending?

IDEA (Individuals with Disabilities Education Act) Grants are federal funds allocated to support special education programs and services for children with disabilities in the United States.

**Ensuring Access to Education:** IDEA grants aim to ensure that children with disabilities have access to a free and appropriate public education.

**Providing Specialized Services:** These funds are utilized to provide specialized services, resources, and accommodations tailored to meet the unique needs of students with disabilities.

**Promoting Inclusive Education:** IDEA grants promote inclusive education practices, encouraging the integration of students with disabilities into regular classroom settings whenever possible.

## **Key Areas of Spending**

**Personnel Training:** Investing in training for teachers, aides, and support staff to effectively meet the needs of students with disabilities.

**Specialized Instruction:** Funding for specialized instruction, therapies, and interventions to support academic and developmental progress.

**Equipment and Materials:** Acquiring adaptive equipment, technology, and materials necessary for accommodating diverse learning needs.

**Parent and Community Engagement:** Allocating resources for parent training, outreach programs, and community involvement to foster support networks.

# **Proportionate Share**

Proportionate share refers to a provision within the Individuals with Disabilities Education Act (IDEA) that requires local educational agencies (LEAs), such as school districts, to set aside a portion of their federal IDEA funding to provide equitable services to students with disabilities who are enrolled in private schools.

We evaluate all kids, but primarily provide speech services and consultation regarding academics.
