### Regular Meeting

**December 15, 2025**

The Board of Education of Lemont Township High School District 210, Cook and DuPage Counties, Illinois, met for its regular meeting in the Board Room on Monday, December 15, 2025, at 6:00 p.m.

#### **Call to Order**

President Korte called the meeting to order at 6:00 p.m.

#### **Commencement of Closed Session**

However, a meeting to consider an increase in compensation to a specific employee of a public body that is subject to the Local Government Wage Increase Transparency Act may not be closed and shall be open to the public and posted and held in accordance with this Act. Ken Parchem, Chief School Business Official, shared the financial reports as of November 30, 2025; information on property and casualty insurance renewal; a recap of the 2025 tax levy; and school fees for the 2026-2027 school year.

Dr. Maxwell, Superintendent, shared an Impact Aid Update. Tony Hamilton, Director of Communications shared the draft proposal of the school calendar for the 2026-27 school calendar.
