ADJUNCT FACULTY AGREEMENT

THE STATE OF TEXAS
COUNTY OF Wood

On this date, at regularly scheduled and posted meeting, came the Board of Trustees of the Mineola Independent School District, hereinafter referred to as "District." A Quorum having been established, the Board proceeded to consider the appointment of the herein named individuals as adjunct faculty members of the Mineola Independent School District.

Upon consideration and vote of _____ in favor to Angie Monk, and Clint Perkins are hereby named as adjunct faculty members of the Mineola Independent School District subject to the following conditions and provisions of such appointment, to wit:

1. This appointment shall commence on the 1st day of August, 2013 and end on the 30th day of May 2014, being the end of the 2013-2014 academic year.
2. Adjunct faculty members will receive no compensation, salary, or remuneration from Mineola Independent School District.
3. Adjunct faculty members are and shall remain employees, in good standing, of the Texas Agricultural Extension Service.
4. Adjunct faculty members shall be under the direct supervision of either the District Extension Administrator of District 5, Extension District, or Wood County Extension Director.
5. Adjunct faculty members shall receive all group insurance benefits, workman's compensation insurance benefits, unemployment insurance, and any and all other plans for the benefit of Texas Cooperative Extension employees. District shall have no responsibility for any of such benefits or plans.

Adjunct faculty members shall direct the activities and participation of students of the school district in sponsored and approved activities as designated from time to time by adjunct faculty members for which notice shall be given to School District administrative personnel. Adjunct faculty members' activities and participation with students of the School District are directed, supervised, and controlled by and through Extension Director or County Extension Director. Adjunct faculty members are not the employees of School District, and School District does not nor shall not supervise, direct or control the activities and/or participation of such Wood County Extension Agents who has been herein designated as a adjunct faculty members.

This appointment is made by Independent School District by and through the Board of Trustees of said district for the benefit of allowing voluntary student participation in programs conducted by Texas Cooperative Extension in recognition of the educational benefits arising from such participation and activities and/or directed by Texas Cooperative Extension. This appointment is made in accordance with the provisions of Section 129.21 (k)(1) of the Texas Administrative Code authorizing the school to deem such participating students in attendance for foundation school program purposes.

This appointment of the herein named Wood County Extension Agents (Extension employee) are not intended nor shall be construed as a waiver of any claim or defense of sovereign or governmental immunity from liability now possessed by Mineola Independent School District or any of its employees, agents, officers, and/or board members in the performance of governmental functions.
