#### BACKGROUND INFORMATION:

State statute requires that changes in the Budget adopted by the School Board at their June 2013 meeting and amended at the August 12 and at the October 21st meetings, must be approved by the School Board if they change the major revenue sections of the budget or if they move money between expenditure functions.
