Item Name: CONSIDER APPROVAL OF RFP #04-2023SE FOR AWARDS, CUSTOM APPAREL, & PROMOTIONAL ITEMS (SUPPLEMENTAL)

Item Summary: The purpose of RFP #04-2023SE Awards, Custom Apparel, & Promotional Items is to add additional vendors. RFP #04-2023SE is a supplemental award to RFP #13-2021RL and RFP #02-2022RL. This type of award is beneficial to the District as it allows campuses and departments a variety of vendors to select from, while ensuring that the District is compliant with purchasing regulations according to TEC 44.031.

This proposal will be awarded as one-year term contract with three automatic one-year renewal options. Contract term may include a District election to add formal subsequent proposals. Either party may provide a 30-day advance written notice of intent to cancel prior to the annual termination.

Recommendation: Administration recommends that the Board of Trustees consider approval of additional vendors which submitted proposals.
