BOARD MEETING

The Regular Meeting of the Board of Trustees of the Aledo Independent School District was held on Monday, December 16, 2013, beginning at 7:00 P.M. in the Aledo I.S.D. Board Room with the following members present: President Jay Stringer, Vice President David Davis, Steve Bartley, Bobby J Rigues, and Hoyt Harris.

AGENDA

President Jay Stringer called the meeting to order at 7:00 P.M.

President Jay Stringer determined a quorum was present at this time.

Mr. Jason Beaty, McCall Elementary Principal, led everyone in the pledges of allegiance to the United States and Texas Flags. The McCall Student Council and Mrs. Reynolds, STUCO Sponsor, introduced themselves, and reported on the many service projects they have completed this year including collecting 4000 food items and participating in the Patriot Paws program.

Dr. Derek Citty, Superintendent, reported on several district events including the annual Christmas Come & Go lunch on December 19. Dr. Citty discussed that Good Friday, April 18 and Memorial Day, May 26, 2014 will be used for two of the four bad weather makeup days. He stated that it will be determined in April or May 2014 on how the other two bad weather days will be made up.

- ~ Superintendent Entry Report Dr. Derek Citty, Superintendent, gave a power point presentation showing the process he used in getting to know the District and community and a compilation of the input he received.
- \sim HB 5 Ms. Denise Dugger, Executive Director of Professional Development and Accountability, presented a time line on the new requirement for district accountability that evaluates performance in community engagement which must be evaluated and reported to TEA by August 2014.
- ~ Local Educational Agency Report Ms. Cheryl Wooten, Director of Special Programs, reported the Aledo ISD is in compliance and eligible for the status of Meets Requirement for Determination and is eligible to voluntarily reduce Maintenance of Effort.
- ~ K-5 Capacity Comparison Dr. Derek Citty, Superintendent, gave a power point presentation with capacity projections from 2012-13 to 2023-24. Next month he will bring to the Board recommendation to form a committee to look at long range plans.
- ~ Potential Refinancing of Series 2005 A Bonds Earl Husfeld, CFO, reported that it would be in the best interest of the District to delay refinancing any of the District's outstanding bonds until we receive information relative to the Standby Bond Purchase Agreement in March 2014.
