# 6A. Midway ISD School Health Advisory Council (SHAC) Roster

# 7. Presentation/Discussion Items

#### 7A. Monthly Finance Report and Tax Rate for 2025-2026

The Midway ISD financial report for the month of July, the first month of fiscal year 2026, was presented by Wesley Brooks. The adopted budget for fiscal year 2026 includes a \$3.5 million deficit. This budget increased to \$4.2 million deficit due to budget amendments from projects budgeted last year but not completed

The District received certified property values from MCAD at the end of July and the property taxable values decreased by 4.66% from the previous year. The main reasons for this decrease are an increase in the homestead exemption and more property protests than normal, leading to increased reductions by the appraisal review board.

# 7B. Senate Bill 13 (89R) – Library Materials

Dr. Becky Odajima, Assistant Superintendent of Teaching and Learning, discussed Senate Bill 13, which was adopted by the 89<sup>th</sup> Legislature, and will take effect on September 1<sup>st</sup>. This bill requires school boards to adopt a policy for the acquisition of library materials before the first day of the 2025-2026 school year.

The district recommended that the Board adopt the EFB(LOCAL) – ALT policy. It will comply with legal requirements, implement new processes, and evaluate whether these measures sufficiently address the needs of our students, parents, and community.

# 7C. House Bill 121 (89R) – School Resource Officers

Dr. Allen discussed House Bill 121 requiring the board to annually examine a "good cause exception" for not having commissioned peace officers on every campus. MISD will recommend continued reliance on the good cause exception allowed by House Bill 3 due to lack of funding.
