I. ESL/Emergent Bilingual Program Evaluation Report

### IV. School Bus Fleet and Clean School Bus Grant Update

Chief Financial Officer, Gary Browning shared the following information: The Texas Commission on Environmental Quality (TCEQ) is offering the Texas Emissions Reduction Plan (TERP) Grant that will help replace school buses meeting criteria outlined in the grant guidelines. Graham ISD has five buses that would be eligible for replacement under the grant. Trustees received an overview of the GISD bus fleet, safety belt status on these buses, and details of the grant and how it may benefit Graham ISD.
