COMMITTEE REPORTS

Finance

Commissioner Vibert reported the committee met on Monday, February 11, 2019; very little has changed since last month and it appears that we are still looking at a substantial deficit; however, there is no revenue documented yet.

There is a Special Finance Committee meeting scheduled for Monday, March 11, 2019 in the BOE auditorium. There is one item on the agenda and it is to present and approve the Superintendent's budget and send it to full board for discussion and a vote.

Policy

Commissioner Taylor reported that the committee met on February 11th and discussed two policies that are on the agenda for revision.

Student Achievement

Commissioner Dube stated the Student Achievement Committee met on February 20, 2019. Dr. Carbone went over the restorative practices at that meeting. In addition, there was an update on the Memorial Boulevard Intradistrict Magnet School regarding programming and transportation.

CHAIRMAN REPORT

Chairman Wilson recognized and thanked the board members for their work on this board as well as their other committees.

Cindy Bombard – President of the Central CT Chamber of Commerce and spoke of the many values of Bristol Tech Advisory Committee. She discussed the mission, the goals, the history and the accomplishments of this group. They continue to work and progress with educators and businesses in developing pathways to offer opportunities to those in the healthcare, construction, and manufacturing fields. Cindy Bombard will be presenting again at the City of Bristol City Council meeting on Tuesday, March 12, 2019.

Pending Legislation

Chairman Wilson testified at the capital regarding magnet school funding. If the state does not fund more money to this, it will become an unfunded mandate. They are currently having public hearings for many potential bills.

MBIAMS Update

Dr. Dietter stated the building committee met twice in February. On February 14, 2019, it was regular business and the discussion of the communication protocol. You can now get information for this project on both the city website as well as the BOE website. On February 28, 2019, the committee convened and had presentations from supporters of PLA and open shop as well as a presentation from Carly Fortin regarding the programming.

STUDENT REPRESENTATIVE REPORTS

Bristol Central Student Representative Abby Tijhuan Grant-Christie shared with the board how Bristol Central celebrated black history month. She is proud to attend a school that teaches about the history of minorities and that it is not forgotten. The National Honor Society held a dodgeball tournament with BEHS. It included teachers, students, and alumni. The money raised was donated to St. Vincent DePaul. The junior class received their National Junior Honor Society applications. They will be holding a Semper Fi fundraiser in the gym. Although it is during the school day, people will be able to participate during gym class as well as after school. The funds received from this will go to disabled veterans. Abby also shared her experience of being a part of the AVID program.

Bristol Eastern Student Representative Logan Zdun also shared how Bristol Eastern celebrated black history month. Some classes have been reading and listening to Malcolm X. In addition, they learned civil rights vocabulary. They read the "Letter from Birmingham Jail" and listened to James Earl Jones. They understand that the civil rights movement has meaning to them. The school held an African American read-in at the library. BEHS is following the Sandy Hook Say Something Promise. If you see any intolerable act of violence, bullying or threats, say something.

Chairman Wilson shared that March 20, 2019 is "CABE Day on the Hill." If you want to attend, please coordinate with Susan Everett and he will be sure to meet you and make sure there is seating. It starts at the Bushnell and continues at the Capitol.

SUPERINTENDENT REPORT

Dr. Moreau thanked the commissioners as well as the community for taking part in "Read Across America" and reading in the schools. Kindergarten registration started on March 1, 2019. If you know anybody with a child that will be five years old on or before January 1, 2020, please register them at the Board of Education Central Registration Office.

The Connecticut State Department of Education released its findings for the accountability index. Bristol is at 75.3% for college and career readiness. The CT state average is at 74.9%. Last year, we fell short of the state average at 72.9%.

Equity and AVID

Carly Fortin, Office of Teaching and Learning Director presented information about the number of students who participate in two or more AP, ECE, or CTE classes. This number has increased over the past three years. She displayed a map that shows Bristol's performance in comparison to the surrounding towns. She feels those positive statistics are a result to the AVID students enrollment in AP and ECE courses. She recognized the AVID teachers who all play a vital role in the success of the program. They are: Latanya Farrell (BCHS), Kelly McCabe (BCHS), Corey Nagle (BCHS), Elizabeth Burdelski (BEHS), and Carolyn Kielma (BEHS).

AVID students took to the podium to express their gratitude and success for and because of the program.

Lori Chen is a first generation college bound student and appreciates the AVID program. She feels she is 100% united with the other students within the program. To date, she has been accepted into one college so far.

Abby King likes that she can ask for help within this program with no judgement. She was able to let go of her fear of AP classes and she appreciates the support of the AVID family.

Alyssa Gonzalez is also in the AVID program. Her goals are to stay focused and to go to college. She has learned how to study and how to learn to be successful.

Noellymar Velazquez had never taken accelerated classes and AVID helped her to figure out learning strategies. She is unsure of her path after high school but knows she will be prepared and ready for college. To date, she has been accepted into all ten schools that she has applied to.

Equity and AVID – con't

Ray Peters is involved in cross country, indoor and outdoor track, and is a police explorer. Prior to high school he didn't do his homework; he didn't think it mattered. Once he began in the AVID program, he learned the importance of effort. This next year he will be taking two AP classes. He has grown from his wants in 8th grade to now and his choices are preparing him to be college bound.

Commissioner Caggiano stated the NAACP had its grand opening on Saturday, March 3, 2019. They opened at 55 South Street, office hours will be Monday through Friday 9:00 a.m. to 1:00 p.m.

Commissioner Dube spoke on behalf of Commissioner Giantonio: There is a mock PPT meeting on Tuesday, March 12, at 6:30 p.m. at Chapter 126; registration is not required. There is a special education day at the capitol on Wednesday, April 3, 2019. Commissioner Dube shared that West Bristol celebrated Read Across America. In grades 2 - 5, they were asked to write an essay about who their superhero is. The students participated in "Jump rope for Heart" and they raised \$5,500.00 for the American Heart Association.

Chairman Grabowski read to 5th graders at South Side School and is pleased with the critical thinking skills the students have.

Commissioner Vibert read to first graders at South Side School for Read Across America.

Commissioner Taylor talked about a meeting at Greene Hills School on March 7, 2019. Rick Miller, the CEO of Kids at Hope will give a presentation about the Kids at Hope framework. On Thursday, March 14th at 6:00 p.m. there will be a presentation regarding Ted Talks that was researched and presented by the students in the gifted program.
