b. BP 0410 Nondiscrimination in District Programs and Activities

Craig Public School District employees may not direct or otherwise compel a student to personally affirm, adopt, or adhere to, or provide a course of instruction or unit of study that directs or otherwise compels a student to affirm, adopt, or adhere to, the following tenets:

- a given sex, gender, race ethnicity, religion, color, or national origin is inherently superior or inferior;
- an individual should be treated adversely based on the individual's sex, gender, race, ethnicity, religion, color, or national origin; and
- an individual, by virtue of the individual's sex, gender, race, ethnicity, religion, color, or national origin, is inherently responsible for actions committed in the past by other members of the same sex, race, ethnicity, religion, color, or national origin.

VOICE VOTE: 3 in favor and 2 opposed. Motion carries.

Tristan wishes to amend the motion to include gender.

M/S: Douville/Dillman.

VOICE VOTE: Unanimous.

All in favor to pass BP 0410 as appears above.

c. CCSD Spring 2021 PEAK Assessment Reports District level assessment. Spotty data. State moving to new testing platform. Information item only.
