The School Health Advisory Council (SHAC) met four times this school year, made recommendations, and sponsored events. HISD activities implemented this school year due to SHAC support include:

- 1. A Health Fair was held at Northside Intermediate School on February 13, 2025, for all students with booths that focused on handwashing, physical activity (blender bike), the effects of vaping, information on the amount of sugar in our favorite drinks, and the UT Tyler School of Medicine with information on their medical program.
- 2. SHAC reviewed the teen empowerment program, Excellent Teen Choice, and voted to not move forward with the program at this time
- 3. In compliance with HB 3908, also known as Tucker's law, the Texas Department of State Health Services held presentations at HMS and HHS in April.
- 4. The Texas Department of State Health Services also held presentations on the effects of vaping for HMS in April.
- 5. SHAC heard a presentation from Justice of the Peace, Jana Enloe, and Fire Marshall, Patrick Dooley, on what they are seeing on the streets and in the courtroom as far as drugs and the impact they are having on the community. SHAC would like to have an outreach for parents and the community to share this information.

SHAC is required to meet four times per year. The meeting dates for the 2025-2026 school year are scheduled for September 16, 2025, November 18, 2025, January 20, 2026, and March 17, 2026. Meetings will be held in the HISD Board Room.
