Superintendent Dr. Brad Hunt discussed the 2021-2022 planning and gave a COVID update assisted by Angela Brown, Executive Director of Communications & Community Engagement; Dr. Angie Applegate, Assistant Superintendent of Curriculum & Instruction; and Dr. Greg Axelson, Chief Operations Officer.

**ACTION ITEM**

A motion was made by Tracy Fisher to make mask optional for outside recess or PE effective immediately through the end of the 2020-2021 school. Anthony Hill seconded the motion. Tracy Fisher withdrew her motion following discussion.

David Caviness moved to amend the prior motion to read as follows:

Every student, teacher, staff member, and visitor shall wear a mask or face shield over the nose and mouth when on school district property or at a district event wherever it is not feasible to maintain proper social distancing from another person not in the same household; provided, however, that this mask requirement does not apply to the following:

- Any elementary school student while participating in outdoor PE and recess;
- Any person with a medical condition or disability that prevents wearing a mask;
- Any person while the person is consuming food or drink, or is seated in a dining area to eat or drink;
- Any person while the person is actively exercising or engaging in physical activity;
- Any spectator or participant at an outdoor event or activity;
- Any student while actively participating in an activity where it is impractical to wear a mask or face shield;

During the period from June 1, 2021 to August 6, 2021, all CISD facilities would be mask optional provided social distancing requirements are followed.

Manish Sethi seconded the motion. The motion passed 7-0.

David Caviness made a motion to amend his amendment motion to add an effective date of May 5, 2021. Manish Sethi seconded the motion. The motion passed 7-0.

A motion to adjourn the meeting was made by Leigh Walker and seconded by David Caviness. The motion carried 7-0. The meeting was adjourned at 8:09 p.m.
