5.1 Student and Staff Enrollment, October, 2015

Dr. Cumblad reported to the Board the Student and Staff enrollment, October, 2015. Enrollment has increased by eight students this past month. Another four students are anticipated to start. New Directions has received referrals from Sycamore and DeKalb. Staffing is as expected.

5.2 Administrative Liaison Meeting Minutes, October 26, 2015

Dr. Cumblad shared the minutes from the Administrative Liaison Meeting on October 26, 2015. Highlights included: combining NIA and Administrative Liaison meetings, professional development and coaching update, ELL students and services, the number of students who will need a high school autism program in the next four years, and 12+ guidelines.

5.3 Report on School Improvement Day activities, October 9, 2015

Dr. Cumblad reported to the Board on the very productive activities by the staff on the most recent School Improvement Day regarding student growth activities.

5.4 IDEA Grant Updates

Nancy Sporer presented the IDEA Grant Update to the Board. A summary of the initial amounts and carryover for the IDEA Flow-through and Preschool federal grants was provided.

5.5 Family Connections

Dr. Cumblad reported that the Family Connections Program has begun. The social workers have worked to create a mentoring program for Mid-Valley families.

5.6 Reminder: Program Withdrawal Notification

Dr. Cumblad reminded the Board that if any of the districts plan to remove students that would potentially eliminate a section or withdraw from a program or service, the district should notify the Executive Director with their preliminary notice by December 1, 2015.

For Discussion

6.1 Unified Calendar Discussion

There was a lengthy discussion about the School Year Calendars for 2016-17. At this time, no calendars are firm for the upcoming school year. Discussion will continue at the December Board meeting.

6.2 ESY Dates

The ESY dates were discussed. Because the 4_{th} of July falls on a Monday and the 5_{th} of July is also a holiday, the Board discussed having ESY for 5 weeks with the exception of those two holidays. The Board has asked for additional information to review at the December Board meeting.

6.3 High School Programming for Students with Autism

Dr. Cumblad shared a chart showing current enrollment and projected number of students with autism that will be entering high school over the next four years. Discussion included available space in middle schools and high schools, and tuition costs verses private placement.
