Elementary Disciplinary Matrix-Approved July 2023

A. Disciplinary action may include but is not limited to:

Meeting with the teacher, counselor, or principal Detention

Loss of school privileges Modified school programs

Parental conference with school staff Removal from class

Suspension (In-School or Out-of-School) Exclusion

Expulsion

B. Five levels of disciplinary action have been recommended by Lakeview staff:

All Level 1 and Level 2 could also include a "Natural Consequences" at the discretion of the teacher/administrator. Examples include apologies to the person harmed; walking if caught running; custodial duties if behavior caused more work for custodians; etc.

The age of the student will be considered when appropriate. The staff has set a natural break in consequences between K-2 and 3-6. When children in K-3 have violations in levels 4-5 consequences may be adjusted with input from behavior specialist and teacher.

The principal has the discretion to adjust consequences depending on the results of the investigation. Additionally, unlisted behaviors that arise will be placed in the appropriate level by the principal.

The fact that a student is in an extracurricular or community education activity does not excuse him or her from consequences. Students who are serving and out of school suspension may not attend activities on the day of a suspension.
