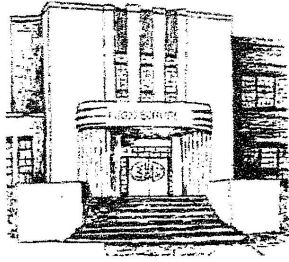

AGREEMENT FOR TRANSPORTATION SERVICE

This Agreement for Transportation service for a tour of sites (The Agreement) entered into by and between the Tupelo Public School District ("TPSD") and Tupelo High School Class of '59 Reunion Committee ("Contractor") as of the 15 day of April, 2009.

WITNESSETH:

WHEREAS, Contractor is having a fiftieth anniversary reunion of the Tupelo High School Graduating Class of 1959 on May 15th and May 16th, 2009, in Tupelo, Mississippi, and

WHEREAS, Contractor desires that TPSD provide a TPSD "Golden Wave" bus to transport classmates on a tour of various sites in Tupelo, including but not limited to schools and Elvis Presley's Birthplace, on May 16th, 2009, and

WHEREAS, Contractor agrees to provide and/or pay for fuel for the operation of the bus and to pay a state and federally approved TPSD employee to operate the bus(es) to transport the classmates.

WHEREAS, TPSD possesses a bus(es) to transport the classmates,

NOW THEREFORE AND IN CONSIDERATION of the mutual covenants and agreements contained herein, the parties hereby agree as follows:

1. TPSD will provide 2 bus(es) to transport the classmates to various sites on May 16, 2009, so long as Contractor complies fully with the terms and conditions contained in this Agreement for Transportation Services.
2. Each classmate agrees to execute, before entering the TPSD bus for the tour, an indemnifying agreement holding TPSD harmless for any injury or damage incurred while entering or exiting the TPSD bus during the tour.

IN WITNESS THEREOF, the parties hereto have caused this Agreement to be executed by parties duly authorized to do so.
