The District has received an adequate number of Community and Parent applications to fill the 2016-17 SHAC Membership vacancies. No further recruiting or advertising is necessary.

The Board of Trustees shall consider, but is not limited to, written applications that are submitted by any eligible person desiring to serve on the Council.
