




BUDGET - 100 GENERAL FUND





- FY26 General fund revenue budget is set at \$10,014,891 expenditures budget is set at \$9,835,857 transfers out budget \$338,000.
- Expenses and revenues are including transactions from July 1, 2025 through September 30, 2025.

• Encumbrances include payroll for the remainder of the year and major overhead expenditures (i.e. electricity, heating oil, etc.).



MORE UPDATES

- The Elementary School Food Service Program for the 2025-2026 school year is not covered under CEP (Community Eligibility Provision).
 - Notices have been sent out and applications have been coming in from RJES families. We still need applications from 28% of the student body.
- The Activity Fee assigned to secondary students has been rolled out. We have received 15% of the fee payments (9% paid 6% waived per household cap).

GENERAL UPDATES

- Convergent, working with Phoenix and TechOps, has been working on migrating the districts surveillance cameras to the new Genetec server. We have successfully brought all camera's online and have the stream successfully recording on our prior server. We anticipate within the next couple weeks that we will migrate the storage of the surveillance camera's footage to the Genetec server.
 - We will be implementing a plan to buy new surveillance cameras to replace some old Mobotix cameras. Storing the footage of these older camera's is taking a significant amount of storage space on the server. They are functional, but we would like to replace these cameras within the next few years.
- For the district's connectivity throughout buildings, we use wireless access points (WAP). We are working with TechOps to get a plan in place to make sure we have enough WAP devices to ensure connectivity for school operations. Additionally, a plan for replacing older WAP devices.
- We are preparing an updated Technology Handbook (previously called the Digital Handbook). We are aiming to have it on the November Board Agenda for approval. This will allow the process around technology to be clear and allow for the any necessary fees to be assessed and collect them.
- Due to the cost of Apple products and the management to maintain the devices, the district is planning to move all students to Chromebooks for the 2026-2027 school year.

RUS-DLT GRANT

- We have received 87% of the AV equipment. We anticipate the remaining items to be received October 22nd.
- The first installment of the AV equipment will be during Spring Break in March 2026. This will allow for the least amount of disruption to the classrooms for learning.
