## **Timeline of Smithville ISD Safety & Security Upgrades**

- October 16, 2017 STOP!T
  - o Began implementation of anonymous reporting system for Smithville ISD
- February 16, 2018 Standard Response Protocol
  - Began implementation of Standard Response Protocol as part of Smithville ISD emergency response plan
- March 27, 2018 Security Assessment
  - Contracted with Combs Consulting Group to conduct district-wide Security Assessment
- April 3, 2018 SJHS Security
  - Added security measures to new Smithville Junior High construction project (cameras and controlled access)
- May 15, 2018 Combs Security Assessment
  - Received Security Assessment & Cost Analysis Report from Combs Security for Smithville ISD
- June 4, 2018 Safety/Security Priority Recommendations
  - Based on Combs Security Assessment and internal administrative discussions 4 Phase I recommendations (SRO, access control @ SHS, perimeter fencing @ SES, perimeter fencing at BP) and 1 Phase II recommendation (secure vestibules @ all campuses) were presented to the Smithville ISD school board
- August 14, 2018 School Resource Officer
  - Memorandum of Understanding signed with City of Smithville to share cost of providing 1 SRO to SISD
- August 16, 2018 Raptor Visitor Management
  - Implemented the Raptor Visitor Management system to better control visitors, contractors and volunteers on campus
- October 4, 2018 SISD Board Security Workshop
  - Board workshop to discuss Smithville High School security upgrade plans
- October 18, 2018 High School Security Upgrade
  - Approved Combs Consulting to complete specifications for access/instrusion/video and secure vestibule proposal and to lead the preparation, solicitation and bid process for this upgrade
- November 13, 2018 Public Safety Meeting
  - Public meeting held to discuss current district safety protocols, plans for the future, and to solicit feedback from the public
- March 28, 2019 Smithville High School RFP
  - Request for Proposals issued for High School Security upgrades (access control system, additional cameras, new intrusion alarm)

- April 29, 2019 Selection of Security Contractor
  - SISD Board approved Knight Security to complete SHS security upgrades
- August 15, 2019 CRASE training
  - Lockhart Sheriff's department conducted Civilian Response to Active Shooter Event training for secondary staff
- September 3, 2019 School Guard
  - School Guard purchased for campuses to provide active shooter alert capabilities to SISD staff
- January 22, 2020 School Safety & Security Grant Submitted
  - Grant proposal submitted to defray costs of 1) 2-way radio for district emergency communication and 2) perimeter fencing at elementary campus (\$29,158 = total grant award)
- April 30, 2020 Smithville Elementary Access Control/Security Fencing
  - Combs Consulting accepted to provide design, RFP documents and construction administration of security fencing/access control to SES perimeter
- May 21, 2020 Smithville Elementary RFP
  - Request for proposal issued for Smithville Elementary access control/security fencing project
- June 15, 2020 Selection of Fencing Contractor
  - SISD Board approved Swift Corp to complete SES access control/security fencing
- September 1, 2020 Smithville Elementary
  - Security enhancement to newly renovated Smithville Elementary campus operational (fencing/access control, secure bus gates, secure vestibules)
- June 17, 2021 Brown Primary RFP
  - Request for proposal issued for Brown Primary for security fence installation
- July 19, 2021 Selection of Fencing Contractor
  - SISD Board approved Swift Corp to complete Brown Primary security fencing project (including access control on entrance gate)
- September 21, 2021 Smithville Elementary Camera Install
  - Brycomm retained to install 44 interior/exterior cameras on SES campus
- Summer 2022 Tiger Academy/DAEP
  - Will install cameras at new TA/DAEP campus. Additionally add camera at BP controlled access gate.
