5.0 GOVERNANCE

5A <u>BOARD WORKSHOP</u>

5A.1 DISCUSSION OF DISTRICT AND BOARD CALENDAR OF EVENTS
Dr. Jose Moreno presented an updated calendar of events for the months of
December and January to the Board. Also, he provided a calendar of
upcoming required board training workshops for the new board members
to attend. The next board training will be on January 27, 2021, at 6:00 p.m.

For the record, Trustee Ismael Gonzalez was in attendance via Livestream.

5A.2 PRESENTATION AND DISCUSSION OF THE 2020-2021 DISTRICT BUDGET

Ms. Nina Conway presented the 2020-2021 school district budget to the Board, which was approved on August 24, 2020. She reviewed the budget process and stated that the allocation for each department and campus was based on student enrollment. The budget included a 2% salary increase with a \$250.00 Winter Incentive. A waiver is available for the first six weeks because of low attendance during the COVID-19. At this time, the school district is at 86% attendance and could lose around \$578,000.00 in state funding because of enrollment during the COVID-19. The administration is looking at any way that they can save costs because COVID-19 was costing the school district money. Dr. Jose Moreno stated that TEA could extend beyond the three-six weeks; however, it was not guaranteed at this point. Ms. Conway also reviewed the following loans and maintenance tax notes with the Board: 1) A loan to purchase six buses will be paid off next year, 2) HVAC/Lighting retro will be paid off in 2028, 3) Maintenance note for baseball, football, softball will be paid off by 2030, and 4) Bonds for a total of \$76.3 million will be paid off in 2043.

5A.3 PRESENTATION AND DISCUSSION OF COVID-19 RESPONSE PROCEDURES Dr. Jose Moreno reviewed the plan for transition to in-person learning with the Board. The plan included the procedures, medical certification for COVID-19 high-risk exemption, transition meeting request form, and the parent notification letter. The plan requires for all students that are not passing to come back to in-person learning, and the parents would be able to appeal because of a medical reason. As of August 1, 2020, the school district has had twenty-eight (28) employees test positive. Since, September 14th, they have had twenty-four (24) students test positive. The count did not include remote learners. Dr. Daniel Ceballos explained the school district's truancy process to the Board. Also, he will be having a a town hall meeting to inform the community of the change to bring back more of the school district's students.

For the record, Trustee Hector Lopez joined the meeting via Livestream during the discussion of the COVID-19 response procedures.

- PRESENTATION AND DISCUSSION OF ATHLETIC TURF PROJECT Dr. Jose Moreno reported that the athletic turf projects were on time. By next week, they should start to lay out the turf on the softball field and a week later they will start laying out the turf on the baseball field. The football field is projected to be finished by mid-February. The total costs for the cotton bolls for the baseball field and softball field will be \$9800.00, alternative number one would cost \$4992.00 to add a concrete strip close to the scoreboard at the football field, and it would cost \$1872.00 to connect a sidewalk from the bullpens to the dugouts.
- 5A.5 PRESENTATION AND DISCUSSION OF DEMOLITION PROJECT Dr. Jose Moreno reported that the demolition should be completed during the Christmas Holidays.

PUBLIC HEARING ON THE TARGETED IMPROVEMENT PLAN FOR SALAZAR CROSSROADS ACADEMY, SEALE JUNIOR HIGH SCHOOL, ORTIZ INTERMEDIATE, SAN PEDRO ELEMENTARY, AND LOTSPEICH ELEMENTARY

Mrs. Lorena Ceballos presented the Targeted Improvement Plan for Salazar Crossroads Academy, Seale Junior High School, Ortiz Intermediate, San Pedro Elementary, and Lotspeich Elementary Schools. She reported that in 2018 the school district received a letter grade and the campuses received either met standard, met alternative standard, or improvement required. In 2019, the school district and campuses received letter grades for their performance. Also, in 2020, the students did not take the STAR or EOC because of the COVID-19. Once a school district has been identified by the Federal Accountability Rating. the school district has to show for two years that they are progressing in the areas that were identified through the Financial Accountability Rating. In 2019 Salazar Crossroads Academy received a D, Seale Jr. High School received a D, Ortiz Intermediate received a C, Lotspeich Elementary received a C, and San Pedro Elementary School received a D. Under the Federal Accountability Rating, Salazar Crossroads received a Comprehensive Re-identified, Seale Jr. High School received a Targeted Support. Lotspeich Elementary School received a Comprehensive Progress, and San Pedro Elementary School received a Comprehensive Progress. The schools are required to have a Target Improvement Plan approved by the Board, and as part of the process for improvement, the school district is required to engage in a TEA Effective School Framework process to identify areas of focus and to address the Target Improvement Plan. The purpose of the Effective Schools Framework includes a common language, continuous improvement, and alignment. The following principals presented their Target Improvement Plans to the Board: 1) Tony Bonilla, Salazar Crossroads Academy; 2) Maribel Trevino, Seale Jr. High School; 3) Anisa Chavera, Ortiz Intermediate; 4) Laura Cueva, San Pedro Elementary School; and 5) Vanessa Peterson, Lotspeich Elementary School. Their presentations included the 2021 Campus Goal, their focus areas, and their action steps.

This is the second consecutive time that the school district has received a Superior Rating. She explained that the first five questions are critical, and a no answer on any of them the school district would automatically fail with an F or Substandard Achievement. The school district received a yes on all five of them. On numbers six thru fifteen, they are worth ten points. The school district missed it by two points on number eight and by four points on number eleven. The school district received a total of ninetyfour points. She also reviewed the school district's financial strengths, operating cost management, administrative cost comparison (2017-2018 – 13.74% and 2018-2019 – 14.78%), personnel management, tax collections, cash management. and budgetary planning and financial allocations received by the superintendent and board members, outside compensation and/or fees received by the superintendent for professional consulting, and/or other personal services which are also required to be reported to the board members and public.
