# **Background and Rationale:**

TxWARN (Texas Wide Area Radio Network) is a regional public safety trunked radio system used by Texas agencies. It provides reliable, secure, and interoperable communication channels for first responders. Key features include interoperability, reliability, security, and scalability. Integrating with TxWARN allows the District to leverage an existing, proven infrastructure for critical communications and better coordinate with external responders.

The purchase of TxWARN interoperable radio equipment is a necessary investment in the safety and security of HISD. By providing reliable, immediate, and interoperable communication, these radios will significantly enhance our emergency response capabilities, protecting our school community and fostering a safer environment.

The total for this purchase will be \$80,460.80 and will be funded by the State SAFE 1 safety grant.
