SUBJECT: Approval of 2005-2006 Attendance Boundary Modifications

**BOARD GOAL: Academic Excellence
Safe Schools
Community Involvement**

FISCAL NOTES: None

Background Information:

- The process to establish new elementary attendance zone boundaries for the 2005-2006 school year began in October 2004. The new elementary attendance zones are primarily the result of the addition of the district's new elementary school that will open in Fall 2005. This school is located in the City of Colleyville on Precinct Line Road and McDonwell School Road.
- The re-drawing of the elementary boundaries is necessary for the following reasons:
 1. Opening a new elementary campus in the Fall of 2005 in Colleyville
 2. Capacity and overcrowding concerns at certain campuses
- Rules and guidelines that are used when creating new boundaries are as follows:
 1. Trying to keep feeder patterns together as much as possible
 2. Trying to keep subdivisions together as much as possible
 3. Using major streets and natural lines as boundaries as much as possible
 4. Move limited and non-populated areas into areas with facilities with capacity available

Administrative Considerations:

- The revision of the elementary attendance zones resulting from the new elementary school scheduled to open in the fall would affect Hidden Lakes Elementary, Shady Grove Elementary, and Florence Elementary. The target opening enrollment for this new elementary is approximately 400 students.
- The new elementary school in Colleyville will impact the intermediate and middle school feeder pattern as well, in this portion of the district.

- The following are the proposed KISD boundary changes which will take effect for the 2005-2006 school year:

Area(s) Under Consideration For Boundary Change:

A) Portions of Hidden Lakes Elementary & Shady Grove Elementary

Reason: Construction of new elementary in Colleyville and to relieve overcrowding at Hidden Lakes Elementary

B) Area off of Union Church Road in Southlake from Hidden Lakes Elementary into Florence Elementary.

Reason: Relieve overcrowding at Hidden Lakes Elementary

C) All KISD intermediate and middle school students living in Watauga

Reason: Relieve overcrowding at PHIS and HMS; move students into SKI and ISMS

D) Allow "Triangle Area" to remain in PHIS and HMS

Reason: Boundary clean-up

E) Move non-populated areas into facilities with space available. One area includes west of I-35 into Heritage Elementary

Reason: Alleviate potential overcrowding at various campuses including NRES

- The district held two public hearings for these potential attendance zone adjustments. These meetings were held on March 8th at Hidden Lakes Elementary and March 10th at Whitley Road Elementary. We received comments from parents, which include using major streets as boundaries whenever possible, using natural boundaries like creeks whenever possible, keeping neighborhood communities together whenever possible, traffic safety issues, pedestrian safety issues, and transportation issues were also discussed.
- The district calculated the number of students that would need to come out of existing attendance zones. By studying the current and future housing development, the goal was to create new attendance zones that will accommodate the future students that will move into the district over the next several years in the impacted areas.

- Changing attendance zone boundaries is a very emotional and difficult task. The proposed attendance zone boundaries accomplish four objectives:
 1. Creates new boundaries for the opening of the new elementary campus
 2. Shifts students from over crowded schools to schools with adequate space
 3. Takes into consideration future housing developments (new students) that will occur within the proposed attendance zones
 4. Helps stabilize our constantly growing elementary attendance zones for at least a 2-year period, if not longer.

- Attached is the documentation that has been used by KISD to notify our residents of potential boundary changes. Information has been posted on the KISD web-site for months and principals have notified residents in the potential impacted areas along with newspaper articles providing details of the March 8th and March 10th public boundary hearings.

- Other considerations for these boundary changes include:
 1. Grandfather transfers and sibling transfers
 2. Transportation Issues

RE: UPDATE REGARDING POTENTIAL BOUNDARY CHANGES/TRANSFER POLICY CHANGES

Due to the continued housing growth in KISD, the district must begin to look at re-drawing certain attendance zone boundaries. The district will also begin to review the district's current transfer policy. The re-drawing of the elementary boundaries is necessary for the following reasons:

- 1) Opening a new elementary campuses in the Fall of 2005 in Colleyville
- 2) Capacity and overcrowding concerns at certain campuses
- 3) Trying to keep feeder patterns together as much as possible
- 4) Trying to keep subdivisions together as much as possible
- 5) Using major streets and natural lines as boundaries as much as possible
- 6) Move limited and non-populated areas into areas with facilities with capacity available

Further information regarding boundary hearing dates and times will follow in the coming weeks. Please refer to the KISD web-site for information. The following areas could potentially be impacted by upcoming boundary changes:

Reason:

- A) Portions of Hidden Lakes Elementary & Shady Grove Elementary Colleyville
- B) All KISD intermediate and middle school students living in Watauga
- C) Allow "Triangle Area" to remain in PHIS and HMS permanently
- D) Move non-populated area west of I-35 into Heritage Elementary NRES

Construction of new elementary in Colleyville
Relieve overcrowding at PHIS and HMS; move students into SKI and ISMS
Boundary clean-up
Alleviate potential overcrowding at Elementary

KISD Transfer Policy

Due to current overcrowding concerns and continued future single-family residential and multi-family residential growth in KISD, the current KISD transfer policy and practice is under review. This review and any changes to the current policy will be complete in early Spring of 2005. All transfers for the 2005-06 school year will be determined under the revised policy and practices.

Please note, KISD will continue to offer transfers only to campuses that have space available as determined at the time of the transfer request.
