I attended the SASSED Board of Directors meeting on May 21, 2025 at the SASSED Administration Center offices in Lisle. Dr. Dryier reviewed the listing of [meeting dates and BOD members](#) along with the assigned [BOD committee assignments](#). In addition to the multiple business action items included in the [meeting agenda](#), just a few noteworthy items from that meeting...

[FY26 Tentative Budget Recommendation](#) - The SASSED CSBO, Rachel Wisniewski, reviewed the proposed FY26 tentative Budget, which was approved by the Board of Directors.

[2025 Extended School Year \(ESY\) Lease Agreements](#) - The Board of Directors approved lease agreements with three school districts (45, 66, and 202) for the extended school year summer school programs for this summer.

2025-26 Lease Agreements - The Board of Directors approved the lease agreements with 9 member school districts (20, 34, 45, 48, 58, 60, 66, 180, 202) for "housing" the SASSED program classrooms in their schools for next school year.

[Preservation Services, Inc. Contract](#) - The Board of Directors approved a contract with PSI for the replacement of the specific roof sections at the Southeast Alternative School.

[2025-26 Highlights of Programs and Services](#) - The Assistant Executive Director, Dr. Vander Woude, provided an overview of all SASSED programs and services.

[Monthly Enrollment](#) - The Assistant Executive Director, Dr. Vander Woude, reviewed the current enrollments or SASSED programs and related services.

[Buildings & Grounds Update](#) - Dr. Dryier reviewed the capital project for this summer to address deficiencies with the roof at the Southeast Alternative School.

[Strategic Plan Update](#) - Dr. Dryier reviewed the May update to SASSED's Strategic Plan.

[Executive Director's Report](#) - The Executive Director, Dr. Dryier shared her brief report.
