RE: NON-ATTORNEY MAGISTRATE STIPEND

Members:

At a board meeting held on August 23, 2021, a board action (attached) was passed appointing Kimberly Nowak as a Non-Attorney Magistrate and granting her a per week stipend of \$250.00, as well as a weekend on call stipend in the amount of \$125.00. On September 05, 2023, a motion was made to amend said board action to allow the on call stipend to be used towards other individuals who substitute for Kim when she is unavailable (attached). This stipend is only in effect through December 2023.

Per Michigan Court Rule, MCR 6.104 – a Magistrate has to be available 24 hours a day to serve the community. I am requesting the stipend for 2024 be increased. While preparing a proposed budget for 2024, a footnote was added with a requested increase in District Court's 2024 Requested Budget, however it may have been overlooked (also attached).

I have attached a proposed board action with requested increase. Please note, the total stipend for 2024 of \$24,700 remains less than the stipend of the last non-attorney magistrate who left employment in 2021.
