a. Meeting Norms – Jason reviewed and reviewed discussions that took place within Building Leaders, noting that in order to promote the first action statement we need to support with internal operations i.e. District Leadership Team to support our E teams better and create that opportunity for the teams to talk together. This venue would be to highlight things that we are doing from this point forward but less about training that buildings are taking back. Terrell will also highlight items under his report at Board meetings as presentations so the entire community can see this. We would be adding another structure to cover everything to allow E teams and leadership together.

Work won't be done at ESJ but sharing what is being done in buildings will continue and reporting to the Board what is being done at the buildings. The work is being done internally with ESJ sharing out. Mike added that the Board can then push things to Business Services so the Board can decide to approve so we can support all the E teams.

Jason noted that the transition will be made for future meeting to meet our needs.

b. Training: Allyship Presenter: Ralston School

Terrell noted an experience he had at Jessica's when a father thanked him for the program at Ralston. We want students to take the initiative. Scott noted that we checked with the parent of a sibling who was a driver of the program and she is fine now. We have provided space for the chess club as well.
