### 1. Personnel Recommendations

2. Milk, Bread, and Frozen Food Bids – We were limited again this year after only receiving 1 bid for each. Prairie Farms won our milk bid. Milk prices went up by \$0.03 cents, juice prices stayed the same, cottage cheese increased \$0.03, and yogurt increased by \$0.02. Juice prices stayed the same. Aunt Millie's Bakeries won our bread bid. The price of a loaf of bread and all other prices stayed the same. Frozen food and canned good bids were won by MJ Kellner and Kohl Wholesale. Prices increased slightly across the board for both due to an increase in paper goods. MJ Kellner is out of Springfield, IL and Kohl Wholesale is out of Quincy, IL.

Action: Motion to accept the Prairie Farms Milk, Juice, & Dairy Products Bid, Aunt Millie's Bakeries Bread Bid, and MJ Kellner and Kohl Wholesale Frozen Foods Bids for the 2021-2022 school year.

3. Resolution authorizing the issuance of General Obligation Alternate Bonds of the District in an aggregate principal amount not to exceed \$7,000,000 pursuant to the Local Government Debt Reform Act of the State of Illinois, as amended, for the purpose of improving the site of and building and equipping a new school building to replace the Washington Elementary and Lincoln Elementary School Buildings – This is the first step in authorizing the bond sale of \$7,000,000 for improving the site of and building and equipping a new building to replace the Washington Elementary and Lincoln Elementary and Lincoln Elementary and Lincoln Elementary School Buildings. The next steps include: publishing a notice of intent in the local newspaper to begin on July 21, 2021 and to provide the BINA (Bond Issue Notification Act) Hearing Notice in the *Pana News-Palladium* on August, 4, 2021. The Capital Projects Fund 1% Sales Tax monies will be used to replay the bond/interest payment on the bond if they are issued.
