1. **Accept or Deny the LASO 4 selection of grant program(s)** in [eGrants through TEAL login](#).
 - a. Go to [eGrants through TEAL login](#).
 - b. Click on the Grants Tab.
 - c. Click on *Apply for Eligible Grants*.
 - d. Click on *2025-2026 Learning Acceleration Support Opportunities (LASO) Cycle 4*.
 - e. Click on the Application Designation Form (ADC).
 - f. In the ADC form, pick the option that is best for your school system i.e. Option 1: *Apply on Own* indicating grant program selection acceptance or Option 2: *Not Apply at All* indicating decline of grant program selection.
 - g. Once the school system has made the choice, scroll down and click on *Certify and Submit*. Please note that Grantee Officials (typically the Superintendent) will have the ability to certify and submit. For other eGrants roles, this *Certify and Submit* button will appear to be grayed out.
2. **Complete the eGrants application**
 - a. Visit the [eGrants through TEAL login](#).
 - b. Click on the Grants Tab.
 - c. Click on *Apply for Eligible Grants*.
 - d. Click on *2025-2026 Learning Acceleration Support Opportunities (LASO) Cycle 4*.

- e. Click on the Grant Application.
- f. The application will reveal the complete budget schedule for the grant.
- g. Once the application is completed, click on the *Certify and Submit* button.
