 The ROE conducted our annual H-L/S Review on Monday, November 28. All schools did great overall, with only minor notations. The State Fire Marshal was not able to meet with us on November 28th, so there will be additional site visit, but no date has been scheduled at this point.

Lake Land Property Damage

- As Dr. Lett made you aware last week, we had some property damage to the east side of the Lake Land Western Region facility. It was discovered on Monday, November 28th by our custodian that damage had occurred both outside and in to the east wall. No one had reported this to the police, so after investigative work, we were able to make contact with the owner of the vehicle that damaged the facility.
- Longhorn Buildings from Beecher City have already repaired the exterior and our maintenance staff and Don Funneman have completed the interior repairs. The total damage estimate should be under \$1,000. I don't have all the invoices yet, but overall minimum damage. The owner of the vehicle was reportedly not in the vehicle at the time of the incident, so no tickets were issued. The owner is staying in contact with me, and has agreed to make restitution to the district for the damages. I'm awaiting the final invoice from Don Funneman before submitting the billing to this gentleman.
