AGENDA ITEM:

Discuss and consider approval of District Portion of E-rate award for Network Switch Replacement.

For the 2019-2020 Erate Funding Year the District applied for Category 2 Network switch upgrades where needed. After USAC review, the campuses on the following chart were approved with several reductions. The reductions were based on a budget limitation set by USAC for a 5 year window that closed with the 2019-2020 Funding Year. USAC approved an 80% funding amount for the campuses as shown on this chart. In order to receive the funding, the District must agree to fund the remaining 20% of the Funding Request Amount for the approved Campuses. Those numbers are also shown. Since AIM was completely removed from any funding, that campus is removed from further consideration for the 2019-2020 Funding Year.
