

OAK PARK ELEMENTARY SCHOOL DISTRICT 97**RESOLUTION ABATING LEVY ADJUSTMENT CREATED BY
PUBLIC ACT 102-0519 (2022 Tax Year)**

WHEREAS, on August 20, 2021, Governor Pritzker signed into law Public Act 102-0519, which provides that a taxing district's levy will automatically increase to recapture property tax refunds made in the prior 12 months arising from a PTAB appeal, tax objection suit, or certificate of error that reduced a property's assessed value; and

WHEREAS, the County Clerk of Cook County ("County Clerk") has determined that the prior period adjustment for Oak Park Elementary School District 97 ("the District") for applicable tax refunds made in the prior 12 months is \$981,650; and

WHEREAS, pursuant to Public Act 102-0519 the County Clerk has notified the District that it will extend the \$981,650 onto the 2022 tax extension unless an abatement resolution is filed with the County Clerk prior to April 1, 2023:

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education, Oak Park Elementary School District 97, Cook County, Illinois, that this Board of Education hereby authorizes and directs the County Clerk to abate its 2022 Levy Adjustment pursuant to Public Act 102-0519, as follows:
