1. CALL TO ORDER / ESTABLISH QUORUM Presenter: HENRY LUTZ

A. MOMENT OF SILENCE & PLEDGE OF ALLEGIANCE In the absence of President Henry Lutz, Vice-President Tony Ashley presided over the meeting. The meeting was called to order at 6:34 p.m., with a quorum present. Following a moment of silence, Sondra Meil led the Pledge of Allegiance.

2. OPEN FORUM

Judy Burks (Teacher) – Comments regarding a letter from the third grade teachers and addressed to the board, supporting the leadership at Jones Elementary.

Julie Bruce (Teacher) – Read a letter addressed to the board and signed by fifteen staff members, supporting the high school leadership.

3. SCHOLAR OF THE MONTH

Administrator Alma Gutierrez introduced the Guzman family. Katie Guzman is the Scholar of the Month for Jones Elementary. David Ortiz from the Uvalde National Bank did the honors, presenting Katie with a certificate.

4. FIRST GRADE CLASS PRESENTATION

Presenter: CANDI VOYLES

First grade team leader Candi Voyles introduced team teachers Laurel Plunk and Aracelie Wiebush, and then shared a Powerpoint presentation created by Capri Creech and B. Schroeder. Board members were invited to a first grade performance of the Wizard of Oz at tomorrow nights PTO meeting. The first grade will perform twice on Thursday for the school. Math textbook adoption comes up next month. Teachers are looking at Glencoe for grades PK through 12. Glencoe has offerings which include online resources. It is also smart and white board ready.

5. 2008 HISTORIC TAX EXEMPTION RECOMMENDATIONS Presenter: KCHC CHAIRPERSON BILL HAENN

This is our third year to use the Annual Review and Assessment of recorded Texas historic landmark properties, conducted by the Kinney County Historical Commission. One property failed the assessment last year, this year six failed to meet assessment standards. KCHC Chairman Bill Haenn, recommended awarding a thirty percent tax exemption for the Wainwright and Patton homes, and all others with a passing evaluation, twenty-five percent. Failures would not receive a tax exemption this year, but would be able to apply again next year.

A motion was made by John Paul Schuster to approve tax exemptions for 2008 as recommended and presented by KCHC Chairman Bill Haenn. Tony Molinar seconded. The motion carried unanimously.

6. MINUTES

A motion was made by Sondra Meil to approve minutes for the January 14, 2008, regular meeting as presented. John Paul Schuster seconded. The motion carried with Tony Molinar abstaining.

7. BUSINESS & FINANCE

A. QUARTERLY INVESTMENT REPORT

Presenter: MARLA MADRID Though all interest rates are dropping, the district earned more interest this year than last quarter. Lone Star sits at 3.1. The district remains in good standing. Next year the district will go out for bid again.

B. RECAP OF REVENUE & EXPENDITURES Presenter: MARLA MADRID

A financial recap for the month of January was conducted by the board. Expenditures are at 50%. Purchase Orders are winding down. To finalize end of year reports, a deadline of April 1st has been given for PO's.

C. CHECK RUN

The freezer went out over the holidays resulting in a loss of only the top layer of frozen foods. The refinish on the floor is our annual refinishing of the gym floor and auditorium stage.

8. RENEWAL OF MEMBERSHIP IN INDEPENDENT RETAINER PROGRAM

A recommendation was made by Paula Renken to continue working with Walsh, Anderson, Brown, Schulze & Aldridge, P.C. This is the district's third year to participate in the legal retainer program.

A motion was made by Sondra Meil to renew membership in the independent retainer program with Walsh, Anderson, Brown, Schulze & Aldridge, P.C. John Paul Schuster seconded. The motion carried unanimously.

- 9. CONSTRUCTION PROJECTS Presenter: HENRY LUTZ
 - A. PAVING / PARKING LOT BID

Award Bid.

In November the board gave the Superintendent authorization, along with Architect John Graves, to negotiate with Pioneer on the three building projects. Negotiations also took place with 90 West Construction. In December the board awarded bids to Pioneer Concepts. At this same time, 90 West was not ready with their bids for the parking lots. They have since submitted a bid of \$55,610.50, along with a sixty day completion date, for parking at the football field on the new concession stand side. No work would be done to the existing lot. Work would include all property across the street and by the Junior High field house, with asphalt all the way to corner. This would include ten handicap spaces. The fence would be moved in 4 feet. This added an additional \$3,500, which is still a fair bid. Crushed granite would be used, except for the handicap spaces. The district currently has six half lots and three full lots. The district will add the parking blocks and build a fence around it all, possibly a low metal pipe fence.

A motion was made by JPS to award the paving and parking lot bid to 90 West contractors and authorize the Superintendent, up to the amount of \$57,500.00, to complete the parking lot project behind the stadium. Sondra Meil seconded. The motion carried unanimously.

B. PROJECT UPDATES

Presenter: PAULA RENKEN

The district did release \$78,000.00 in funds directly to Mike Bizzell's bonding company. They will in turn release the funds to him.

10. POLICY UPDATE 82, FIRST READING Presenter: PAULA RENKEN

The board conducted a first reading of local update 82, with Paula Renken reviewing local TASB policy recommendations. Legal policy is already in place. Mrs. Renken will recommend adoption next month.

11. GOAL SETTING: 2007-2012 FIVE YEAR STRATEGIC PLAN Presenter: HENRY LUTZ

Due to a shortage of attendees, a recommendation was made to table this agenda item until a workshop can be scheduled to work on district goals.

A motion was made by John Paul Schuster to postpone item 11 in order to schedule a workshop for goal setting. Sondra Meil seconded. The motion carried unanimously.

Board members were asked to contact the Superintendent and let her know what dates are not good for them. Possible dates for the workshop will be given to Board members in the Friday Board Brief.

12. RIDER 86

Presenter: HENRY LUTZ

The board was asked to decide how to allocate Rider 86 money per guidelines set by the state. BISD will receive approximately \$25,000.00 to be divided between SBEC Certificate holders. Those holding certificates include 54 teachers, 2 counselors, 1 librarian, 1 nurse, and 16 paraprofessionals. Administrators hold certificates, but will not be included. The amount comes out to an estimated \$338.00 per person, to be paid in June 2008.

A motion was made by John Paul Schuster to go with the Superintendent's recommendation as outlined. Tony Molinar seconded. The motion carried unanimously.

13. SCHOOL CALENDAR, 2008-2009

Presenter: CALENDAR COMMITTEE REP. CANDY HOBBS

Together Candy Hobbs and Liz Frerich presented the 2008-2009 calendar, thanking Yolanda Rueda, Eileen Allen, April Blake, Tara Edwards, and Louisa Stone for serving on the calendar committee. Staff had the opportunity to vote on two calendars for the 2008-2009 school year. Calendar A is the "tight" calendar and similar to last years, not many holidays and scattered early outs. Calendar B is the 'loose" calendar, just the opposite of last year and with a week off at Thanksgiving and other holidays throughout the year. Voting was close for both calendars, calendar A received 46 votes, and calendar B received 40. Flex days were not included. The first year flex days were done at the end of year. Flex days were split at the end of semesters our second year. Teachers are recommending that flex days be divided and moved to the end of the quarters this year, or coming up with another more creative way to make use of them. Board discussion included the January 9th Stock Show holiday, with the board agreeing to possibly make this an early out and moving this holiday to the end of the year in April or May. Students can still claim an "S' day.

A motion was made by Sondra Meil to accept the 2008-09 school calendar "A" as presented, with possible change to the stock show date. Tony Molinar seconded. The motion carried unanimously.
