Chair Ms. Berg introduced the following Resolution and moved its adoption:

RESOLUTION ENTERING INTO JOINT POWERS AGREEMENT

WHEREAS, public school districts are required to make a full continuum of services available to students with disabilities, including students with low incidence disorders who require intensive special education and related services outside the traditional school setting;

WHEREAS, the District currently does not have an efficient way to serve its students with low incidence disorders who require intensive special education and related services outside the traditional school setting;

WHEREAS, the School Board finds that the District can optimize its limited resources and increase its efficiencies by entering into a joint powers agreement with other school districts to cooperatively serve students with low incidence disabilities; and

WHEREAS, the School Board has carefully reviewed the attached joint powers agreement, which would create a special education cooperative for the purpose of serving students with low incidence disorders;

NOW, THEREFORE, BE IT RESOLVED by the School Board of Independent School District No. 763 as follows:

- 1. The School Board approves and enters into the attached joint powers agreement expanding the membership of the Cannon Valley Special Education Cooperative.
- 2. The School Board authorizes and directs the Board Chair and the Board Clerk to sign the joint powers agreement on behalf of the School Board.

The motion for the adoption of the foregoing Resolution was duly seconded by Mr. Sutherland and upon a vote being taken thereon, the following voted in favor of the motion: Ms. Janke, Ms. Berg, Ms. Jones, Ms. Hemann, Mr. Cronin, and Mr. Sutherland

And the following voted against the motion: None Whereupon said Resolution was declared duly passed and adopted.

Motion by Mr. Sutherland, second by Ms. Janke, to approve the Liability & Workers Compensation Insurance Proposal for 2016-2017, as presented. Motion carried

Motion by Ms. Berg, second by Ms. Jones, to approve a 10 cent increase in meal prices for 2016-2017, as follows: High School Lunch \$2.50, Grades 3-6 Lunch \$2.40, Grades K-2 Lunch \$2.30, Breakfast \$1.55, Adult Breakfast \$2.05, Adult Lunch \$3.80. Motion carried

Motion by Mr. Cronin, second by Mr. Sutherland to approve the 2016-2017 Preliminary Budget as follows: Revenue: \$10,164,547; Expenditure \$9,960,610. Motion carried

Motion by Ms. Berg, second by Ms. Jones, to increase the District Capitalization Threshold to \$5,000, effective July 1, 2016. Motion carried

Motion by Ms. Jones, second by Ms. Berg, to approve the agreement with Clifton Larson Allen to conduct the 2015-2016 audit as presented. Motion carried

Motion by Ms. Berg, second by Ms. Janke, to name Superintendent Rich Dahman as the Identified Official With Authority for the district reporting requirements to the Minnesota Department of Education. Motion carried

Motion by Ms. Berg, second by Mr. Sutherland, to approve the Health Care Savings Plan Memorandum of Understanding as presented. Motion carried
